President's Message

Greetings ISGIDARians!

It is a distinct honor to write this column as the newly elected President of ISGIDAR. I am grateful to have Wendy Lynch, our tireless Treasurer, working behind the scenes to navigate us through our annual finances, and Josh Lile as Secretary, who works hard to keep our membership informed of relevant scientific meetings, job postings, awards, and ISGIDAR news. Additionally, we are thrilled to have the continued support of Justin Strickland and Ryan Lacy who provide their technological expertise to maintain the website, links for meeting registration and donations, and with formatting the newsletter. Lastly, Mark Smith and Drake Morgan have been excellent resources in helping to navigate presidential duties. Of note, they both continue to represent ISGIDAR's voice with STAR (Supporting Truth about Animal Research), a coalition of scientific societies committed to animal research including CPDD, APA, and ACNP. STAR has been instrumental in mobilizing [responses](#) to the FDA's extremely troubling steps to terminate non-human primate nicotine research this past year.

As we welcome 2018, it is impossible to ignore the multitude of substance use related public health concerns that are making front-page headlines. Most monumental is the opioid epidemic that has claimed increasing numbers of lives over the last couple of years. The epidemic has captured the attention of scientists, health care professionals, and politicians alike as the country grapples with determining the best course of action to lessen the threat of these drugs on our nation's health. Simultaneously, more states are passing laws allowing for medical and adult (i.e., recreational) cannabis use, and the popularity of electronic nicotine device systems is raising questions regarding their impact on population health. Exemplifying the public's need for high-quality information related to these three public health concerns are the consensus reports published by National Academies of Sciences, Engineering, and Medicine on [opioids, cannabis and cannabinoids](#), and [electronic cigarettes](#) that have all been published this past year. As members of ISGIDAR, our research is integral in understanding the variables that contribute to the abuse liability of these three drug classes. The work we do is instrumental in identifying strategies to mitigate the harmful effects of these drugs and trends of use, from potential pharmacotherapies to

behavioral interventions.

Treasurer's Message

ISGIDARCOM's finances are pretty solid following the 2017 meeting thanks to registration fees and corporate and private donations. As detailed in the report below, we had 39 regular registrants (full; \$100) and 26 trainee (discounted; \$50) registrants, grossing the organization \$5163.79 (without fees). We received a number of donations to defray our overall expenses, including \$1000 from Pinney Associates, two anonymous donations of \$1000 and \$200, and \$50 from Dustin Stairs. We also received a \$500 donation from Drs. Richard Foltin and Suzette Evans to fund the ISGIDAR travel award, and \$200, \$200, and \$100 from Drs. Freeman, Rowlett, and Nader, respectively, to fund the Woolverton Memorial Travel Award.

Meeting expenses in Montreal were \$5163.79, which is lower than previous years (e.g., approximately \$7930 in 2016 and \$6900 in 2015). The food and beverage costs at the venue in Montreal were particularly low relative to other venues/locations. The USD exchange rate was also highly favorable. These low costs, combined with the increased revenue we received from registration this year (56% higher as compared to 2016), as well as the donations, resulted in an overall surplus of \$2,116.50. This surplus fully offsets the deficit of \$1,157.00 we incurred in 2016, and leaves us with a safety cushion of \$6822.81.

The donations we received for the 2017 meeting allowed us to 1) support travel for two of our in-training members, 2) offer a discounted registration fee for in-training members, and 3) provide a free lunch for all pre-registered attendees/speakers. Donations of this type are needed to maintain these practices. We have already received pledges for donations for this year's meeting from Pinney Associates, Drs. Evans and Foltin, and several individuals (Thank You!). We are also planning to solicit donations to other organizations/corporations to help defray our 2018 expenses and to fund the Woolverton travel award.

Our decision to reduce the waiver for trainee registration from a full waiver, \$0.00, to a 50% waiver, \$50.00 was implemented with the 2017 meeting. The income received from trainee registration was significant, \$1291 (without fees), and definitely contributed to our positive financial standing for 2017. Although the number of registered trainees was lower for the 2017 meeting (28) as compared to the 2016 meeting (37), it was comparable to the number of trainee registrants for the 2015 and 2014 meetings (29 and 25, respectively), and higher than those observed in 2011 (18) when the registration waiver was initially implemented. The ratio of trainees relative to regular (full) registrants was also lower in 2017 (41%) as compared to 2016 (53%), but comparable to those observed in 2015 (41%), and higher to that observed in 2011 (24%). Thus, this new practice did not appear to detract trainee attendance. However, as we do not want to discourage or prevent trainees from attending ISGIDAR, if travel funds are not available, a trainee can request a full waiver.

We will once again accept payments via credit/debit cards. These payments can be made for both registration fees and donations, and can be made either prior to the meeting or onsite. There is a 3% convenience fee added to each payment for registration (i.e., \$103 for full registration, \$51.50 for trainees). However, we have not been able to resolve issues with payments made using international credit/debit cards. As such, our international members will need to either send a check or money order to me prior to the meeting, or bring a check, money order, or cash to the meeting. Remember, we are a 501c3, so your donations are fully tax-deductible. More information, including a link to our Square store, will be included in our call for presentations.

2016 Business Meeting

Minutes Approved on June 17, 2017

Where: Satellite meeting of CPDD in Montreal, Canada.

When: 06/11/16

Who: Mark Smith (President), Wendy Lynch (Treasurer), Ziva Cooper (Secretary), and members

The Business:

- The President (Mark Smith) called the meeting to order at 5:11 pm.
- The President thanked all the speakers for an outstanding program (applause followed).
- The President thanked our corporate sponsors Grünenthal and Pinney Associates for their support of the scientific meeting. The President thanked Suzette Evans and Richard Foltin for their support of the ISGIDAR travel award, and James Rowlett and Kevin Freeman for their support of the Woolverton Memorial Travel Award (applause followed).
- An announcement was made to inform the audience of the Animal Research Forum happening later that week as part of the CPDD program, reminding people to please attend.
- Current statistics on number of visitors to the ISGIDAR.COM website were shared: Over the previous year, there were an average of about 100 views per month and 1000 views over the past year. Big thanks were given to Justin Strickland and Ryan Lacy for helping to maintain the website and helping produce the newsletter.
- The President thanked the Secretary (Ziva Cooper) for preparing the newsletter.
- The Secretary thanked attendees for providing up-to-date email addresses to ensure maximally effective communication throughout the year.
- Past President, Drake Morgan, updated the group on his work with STAR (Supporting Truth about Animal Research) for which he is the ISGIDAR representative for the organization. STAR is a coalition of scientific societies including many of our sister organizations (ACNP, APA, CPDD, etc) that seeks to disseminate the truth of animal research and lobby on behalf of continued animal research tackling issues that are affecting animal research. This past year, the group's voice garnered the attention of Francis Collins, who met with STAR representatives to discuss issues affecting animal research including the closure of the NIH Animal Center and the NICHD Development and Ethology Laboratory in Poolesville, Maryland.
- The President called for approval of the 2015 business meeting minutes and noted that both action items were completed (applause followed). All were in favor of approval.

New Business

- The Treasurer (Wendy Lynch) announced that credit card payments for advance registration and donations are going well. However, there is a 3% charge for the online service (Square) and it's hard to tell who a payment is for especially if it is made by someone else.

Action Item: Efforts will be made in the upcoming year to work on the issues associated with online donations and payment for registration.

- o Budget update: ISGIDAR is currently \$1200 in the red despite the following significant donations. Pinney Associates gave ISGIDAR \$1000, which covered half of breakfast expenses, and Grünenthal contributed \$2000, which helped defray the cost of lunch. Travel awards were donated by James Rowlett and Kevin Freeman for the Woolverton Memorial Travel Award and Richard Foltin and Suzette Evans sponsored the ISGIDAR travel award. ISGIDAR also received a \$25 donation for lunch and a \$500 anonymous donation.

Two reasons for this year's deficit were explained: 1) the venue at Palm Springs was expensive (\$1600 more than costs for the 2014 and 2015 meetings), and 2) we only had 33 paid attendees since we've been waiving registration for trainees. We have great attendance with the 71 attendees; however less than half were paid registrants. Suggestions were made to help with the deficit. The first suggestion was to have trainees pay \$50 (50% of full registration fee). The President asked how many people are trainees (1/2 of the room raises hand) and how many people would come to ISGIDAR if they had to pay (most everyone kept their hand raised). Another suggestion to keep costs down was to move ISGIDAR to an off-site hotel, but the Treasurer reminded the audience that people come to ISGIDAR throughout the day who have to be on site at the main hotel making a meeting at an off-site hotel less desirable. A third suggestion was to cut costs by only having coffee and fruit at breakfast. A fourth suggestion to help defray costs was to cast a broader net for sponsorship; it was suggested that APA Division 28 has contact information of potential sponsors that they could share with ISGIDAR.

The President made a motion to permit the executive committee to institute membership dues / meeting registration fees for members-in-training in an amount of up to 50% of senior membership and to add a condition to allow a member-in-training to request a waiver if he/she is not able to be reimbursed through PI's funding. The motion was seconded and passed.

Action Item: Pursue sponsorship opportunities to assist in ISGIDAR costs.

- o The Treasurer raised the question of the potential conflict of interest regarding travel awards being from the same institution or research group as the donors (i.e., from Columbia University or University of Mississippi) and if it should be added to the bylaws. It was agreed that this was not a conflict of interest and therefore not added to the bylaws.

ISGIDAR Bylaws

Revisions Adopted on June 14, 2014

I. Name and objective

The name of this Association shall be International Study Group Investigating Drugs as Reinforcers (ISGIDAR). The objective of the Association shall be to promote interest in, and to facilitate the dissemination of, new information related to drugs as reinforcers, especially as it may relate to human drug abuse.

II. Membership

1. ISGIDAR shall be made up of Members and Sponsoring Members. Any person holding an academic or scientific degree or working toward such a degree and who is actively engaged in or interested in research related to drugs as reinforcers shall be eligible to become a Member. Sponsoring Membership shall be offered to organizations with an interest in basic or applied research in the field of drugs as reinforcers.
2. Application for Membership: Current ISGIDAR members can submit nominations at the annual business meeting or submit nominations in writing to the President at any other time during the year.
3. Election to Membership
 - a. Individuals nominated at the annual meeting will be elected to membership by a yes vote of 90% of the governing body.
 - b. Individuals nominated directly to the President will be elected to membership by unanimous vote of the Board of Officers. In this case, the results of the election will be announced at the next business meeting.
4. Membership may be rescinded by action of the Board of Officers of ISGIDAR for justifiable causes. Paid dues must be returned to the ex-member along with notification of termination of membership in writing and an explanation of the reason for removal. Any member so removed may appeal this action to the Membership at the first meeting of ISGIDAR occurring more than 30 days following notification of termination of membership by board action.

III. Governing Body

1. Members present at each business meeting of ISGIDAR constitute the governing body provided a quorum is met. A quorum consists of at least two members of the Board of Officers plus at least 10 members. Each Member has one vote. The Membership present at the meeting can decide by simple majority vote about the following items:
 - a. Minutes of the previous meeting
 - b. Acceptance of financial report by the Treasurer
 - c. Dues and Registration Fees
 - d. Future meeting places
 - e. Adoption of a working budget
 - f. Election of officers
 - g. Varia
2. Changes in the bylaws may only be brought about following full discussion at the business meeting. A two-thirds majority of the members present must approve all such changes. Changes proposed at a given business meeting may be voted upon at the same meeting unless a majority

of those present vote to have the proposed change distributed by mail to the membership with the announcement that the proposed change will be voted upon at the next business meeting.

IV. Officers

1. The Board of Officers of ISGIDAR shall be made up of members who serve as:
 - a. President
 - b. Past President
 - c. Secretary
 - d. Treasurer
2. The President shall be elected by majority vote of the governing body for a 2-year term. The term of office begins at the close of the meeting at which a President is elected and ends when the term of the President's successor begins. An individual may serve more than one term as President, but the terms may not be sequential.
3. The Past President will serve on the Board of Officers for two years following the presidency for the same term of office as the President.
4. The Secretary shall be elected for the same term of office as the President by majority vote of the membership present. The Secretary may be re-elected for four (4) additional, sequential terms.
5. The Treasurer shall be elected for the same term of office as the President by majority vote of the membership present. No restrictions are placed on the number of times the treasurer may be reelected.
6. Powers and Duties of the Officers
 - a. President
 1. Arrange and set the agenda for the annual scientific and business meetings
 2. Preside over the annual scientific and business meetings
 3. Preside over all meetings of the Board of Officers
 4. Engage in fundraising and contribute to the financial stability of the organization
 5. Perform such other duties as are incident to the office, including contributing to the long-term stability of the organization and meeting the objectives described in the bylaws
 - b. Past President
 1. Ensure a smooth transition for the President
 2. Provide input on the future, goals, direction, and function of the organization
 3. Complete all agenda items that were not completed during the prior term when serving as President
 4. Assume the President's duties if the President is unable to act
 - c. Secretary
 1. Keep the minutes of ISGIDAR business meetings
 2. Edit and disseminate at least one edition of the Newsletter each year
 3. Serve as Parliamentarian of the organization
 4. Keep and annually update the master membership list
 - d. Treasurer
 1. Receive, disburse, and duly account for all sums of money belonging to ISGIDAR
 2. Submit a written financial report each year to the Board of Officers and at each Business Meeting.
 3. Assist the President in fundraising and contributing to the financial stability of the organization

7. The Officers shall represent ISGIDAR to the public.
8. The President may appoint additional officers as needed. Appointed officers will have defined roles as specified by the President, they will serve at the discretion of the President, and their terms of office will terminate at the end of the President's term of office. An incoming President may reappoint the same individual holding an appointed position for an additional term of office.

V. Meetings

1. Annual Business and Scientific Meetings shall be the responsibility of the President. The President or Secretary will notify all members at least 30 days prior to any business meeting of ISGIDAR
2. Scientific Meetings may be arranged in any format suitable for the communication of information and acceptable to the Board of Officers. Local arrangements will be made by the President or another individual whom the President may appoint.
3. Whenever possible, business meetings will be held in conjunction with scientific sessions. Business and scientific sessions will, insofar as possible, be held at or near the time of other national or international meetings of scientists likely to be of interest to and participated in by members of ISGIDAR.
4. The Board of Officers shall meet at such times and places as are mutually agreeable to Board Members. All Board Members must be notified of such meetings at least ten days prior to the meeting.

VI. Dues

1. Annual dues become payable on or before the annual business meeting of the membership year. The amount of the annual dues and registration fees shall be recommended by the Board of Officers and decided upon by majority vote of the governing body at any business meeting.

VII. Committees

1. Permanent or ad hoc committees shall be established when necessary and their members appointed either by the President or by vote of the governing body at a business meeting.

The objective of ISGIDAR is to promote interest in, and to facilitate the dissemination of, new information related to drugs as reinforcers, especially as it might relate to human drug abuse.
